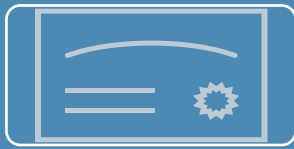

In order to qualify for the designation of '**Accredited Executive Manager**', and use the Post Nominal AEMgr., candidates need to complete all 15 units of competency. By completing the Certificate and Diploma qualifications sequentially, candidates will be eligible for the AEMgr. designation.

Admissions

To qualify for admission to the Accredited Executive Manager Examination, candidates will need to demonstrate prior learning at Senior Management Level, or a comparable qualification, and have at least 2 years' experience in a middle or senior management role.

Examinations

Examinations are conducted online by GIAM, and are available on demand. Your Approved Learning Provider will schedule your examination, and will provide you with the registration and login details. Your preliminary results will be available immediately on completion of the examination. You will receive conformation and your certification within 2 to 3 weeks of completion of your examination.
